It is to inform that vide ref. 1st cited, fake applications were filed in National Scholarship Portal (NSP) under AICTE Pragati & Saksham Scholarship Schemes on the name of SVU College of Engineering, Tirupathi and Vikas College of Pharmacy, Vissannapeta, Krishna District.

Vide ref. 4th cited, the Three members Expert Committee in which the Commissioner of Technical Education, Andhra Pradesh is a member, noticed that the credentials of INO's are shared with unauthorized persons which causes scope of filing fake applications in the name of the institutes concerned. Further noticed that the applications filed by the students are simply submitted to the next level by INO's without proper scrutiny and assurance of correctness of the documents submitted at the institute level. In some cases, improper / irrelevant / not legible documents are being approved at the INO level which causes lot of hindrance.

In this connection, all the Principals of Professional Institutions in the State of Andhra Pradesh are informed to issue necessary instructions to the Institute Nodal Officers (INO's) concerned to scrutinize and verify the applications filed at the institute level before approving them. Applications irrelevant not legible documents with improper / / should be rejected/defected at the institute level only. Such applications if any found at SNO level, they shall be summarily rejected. Further, if any fake applications / discrepancies are found at a later stage, the INO's shall be held responsible and they may face the disciplinary proceedings as per rules in vogue.
