1. *Setting up New Technical Institutions in the following programs at all the levels (Diploma, Post Diploma, Under Graduate, Post Graduate, Post Graduate Diploma in Management, Post Graduate Certificate in Management and FPM (in Management)) etc: (including BBA/BCA/BMS)*
 - *Engineering and Technology*
 - *Planning*
 - *Applied Arts and Crafts*
 - *Design*
 - *Hotel Management and Catering Technology*
 - *Computer Applications*
 - *Management*
2. *Extension of Approval for Existing Technical Institutions, Institutions Deemed to be Universities, or Universities (Central/State/Private).*
3. *Approval/NOC for Open and Distance Learning (ODL) or Online Mode Programs in the following fields for Standalone Institutions or Institutions Deemed to be Universities at certificate / Diploma / Degree:*
 - *Management – Business Administration, Logistics and Travel & Tourism*
 - *Computer Applications - Computer Application, Artificial Intelligence and Data Science, Artificial Intelligence and Machine Learning, Cyber Security and Block Chain.*

Applications for the Academic Session 2025-26 must be submitted online via the AICTE Web Portal.

The time line for submission of online applications for AY 2025-26 is as follows:

Online applications can also be submitted with penalty
from January 18, 2025 to February 2, 2025.

Hence, all the AICTE approved Technical Institutions in the state are requested to go through Public Notice for Approval Process 2025-26 issued by AICTE, New Delhi and file applications by strictly following the time line prescribed.
