As per the Guidelines for Existing Institutes Offering or intends to offer BCA/BBA/BMS courses under AICTE Regulations cited at ref. 2, AICTE, New Delhi brought BCA/BBA/BMS courses under the umbrella of AICTE from the academic year 2024-25 onwards to ensure coordinated development in technical and management education.

All India Council for Technical Education (AICTE), New Delhi has issued the Public Notice cited at ref. 1 for Approval Process for the academic year 2025-26 which also includes the institutions already offering BCA/BBA/BMS courses without AICTE approval or intended to offer BCA/BBA/BMS courses.

This office has already issued a circular memo cited at ref. 3 to the Registrars of all Universities and Principals / Managements of all Government / Private Aided / Private Un-Aided Institutions in the state offering Technical Diploma / Degree / PG courses, intimating the time line for academic year 2025-26 for submission of online applications in AICTE Web Portal.

As the last date for submission of online application (without penalty 13th January 2025 and with penalty 02nd February 2025) is approaching, the Registrars of all Universities are hereby requested to instruct the Principals/ Managements of affiliated institutions offering/intended to offer BCA/BBA/BMS courses, to submit online applications in AICTE Web Portal within the stipulated time to bring those courses under the umbrella of AICTE from the academic year 2025-26 without fail.
