aforementioned guidelines to their affiliated institutions to activate the monitoring  
mechanisms at the institutional level, create awareness among the students on  
Prevention and Prohibition of Ragging and display the anti-ragging posters released by  
UGC in the Institution Campuses, Libraries, Hostels, Canteens, etc., in order to keep  
the Profession Institutions ragging-free.
